## **Abarth - Terms and Conditions**

- 1. The promoter is Fiat Chrysler Automobiles UK Ltd, Pinley House, 2 Sunbeam Way, Coventry, CV3 1ND. Abarth is a trading name of Fiat Chrysler Automobiles UK Ltd (the "**Promoter**"). The Promoter is a member of the Stellantis N.V. group of companies.
- 2. The Promoter operates prize draws at www.facebook.com/AbarthUK/ (each a "**Prize Draw**" and together the "**Promotion**").
